



'The Defense Never Rests' Topic of Weinglass Speech

"The Defense Never Rests," will be the topic of the speech presented by Leonard Weinglass, junior defense attorney in the Chicago Conspiracy Trial, tonight at 8:15 in the Ulmer Planetarium.

Recently in a speech given at Syracuse University, Weinglass stated that he was "impressed by the depth, scope and involvement of so many people to change the insensitive underpinnings of the conditions we live."

During a period of his speech when laughter evoked the attorney said, "This is one of the first times I've heard laughing without fear of repression," as he told his audience, "the Chicago Seven were sentenced 29 days for laughing."

He went on to explain the controversial "Rap Brown law," which prohibits the crossing of state lines with intent to incite a riot. It also defines "riot" as an assemblage of three persons who threaten a fourth person.

The young attorney went on to relate that the original Chicago Eight were indicated the same day that this law took effect.

Weinglass also outlined the problems and intricacies of the judicial system when it acts as repressively as possible in setting up a case. He said that they had set up the most expensive defense ever in a criminal trial.

The lawyer went on to say that many stories were deliberately slanted in spite of the way the newspaper reporters sent them in.

Weinglass condemned the trial as "the grossest injustice in recent American history," and said the plea for a new trial is partially based on post-trial statements of chief prosecuting attorney Foran. He also related of the frustrated efforts of Bobby Seale to defend himself from the charge of conspiring with seven men he did not know.

In concluding he expressed his

desire that the truth and full information reach the people of America on all issues and hoped that the trial partially enabled that to come about.

Weinglass himself faces 14 counts of contempt of court from the trial, with a possible sentence of 20 months and 16 days in prison.

A graduate of George Washington University (Phi Beta Kappa) and Yale Law School, he was a captain in the United States

Air Force, judge advocate general, Keflavik, Iceland.

Presently he maintains his own office for the practice of law in the city of Newark, New Jersey, and representing the following clients: Tom Hayden, one of the founders of Students for a Democratic Society; Jerry Rubin, organizer of the 1967 march on the Pentagon, author of the book *Do It* and co-founder of the YIPPIES; Abbie Hoffman, Rubin's associate co-founder of the YIPPIES and author of the book *Revolution For the Hell of It*; David Dellinger, a pacifist opposed to the U.S. Asian war and who has made several trips to Viet Nam; Kenneth Gibson, candidate for mayor, The Love People (YIPPIE organization at Rutgers University), and Thomas Trantino, convicted of murdering two policemen.

In the past he has represented the following clients: John Butenko, Rutgers engineer convicted of espionage in the longest spy trial in American history; Lekoi Jones, Black Organization of Students-Rutgers; Plainfield residents who were the targets of a massive unconstitutional search by the National Guard and state police - this suit was settled for monetary damages and a formal written apology by the Governor of the State of New Jersey; the Fort Dix black community; and the suit to enjoin the operation of Newark police department

following the 1967 Newark rebellion.

Weinglass has traveled throughout the world and visited Cuba a guest of the government.

Grant For LHS Student

LOCK HAVEN--Steve Harris, a junior majoring in biology at Lock Haven State College, will conduct research on "The Effect of Effluents on Marine Phyto Plankton and Bottom Communities" for the Virginia Institute of Marine Science at Gloucester Point, Va., from June through August, 1970. The project is being sponsored under the National Science Foundation Financed Undergraduate Research Participation Program.

In notifying Mr. Harris of his acceptance, Robert S. Bailey, Project Director, stated, "You have been selected into this program because of your apparent ability to do research and your expressed interest in becoming a research scientist."

Mr. Harris will be assigned to work with a research scientist who has a program already in progress, assist in the research and learn how the scientist solves his problems. He will also be assigned a small area of research to investigate on his own.

The National Science Foundation provides a stipend of \$60 per week, considered not as salary but as payment to enable each participant to work and study. The program seeks to encourage participants to specialize in some phase of marine science at the graduate level.

Students Vote YES On Act. Fee Hike

The student body of Lock Haven State College voted yes overwhelmingly yesterday in adopting a proposed amendment to the Student Cooperative Council constitution which will increase the activity fee at LHS.

A two-thirds majority of those voting was needed to pass the proposal and over 80 percent of those voting cast their ballot in favor of the proposal.

In the balloting 864 students voted for the proposed increase of \$5 per semester and \$2.50 per summer session while 211 voted against the proposed amendment. A majority of 716 was needed to pass the proposal out of the 1075 students casting ballots. The 1075 voters constitutes about 45 percent of the LHS student body in comparison to the 25 percent who voted down the proposal two weeks ago.

The SCC board of directors had passed the proposal last week 42-4 leaving the final question up to the student body. The measure will now go before

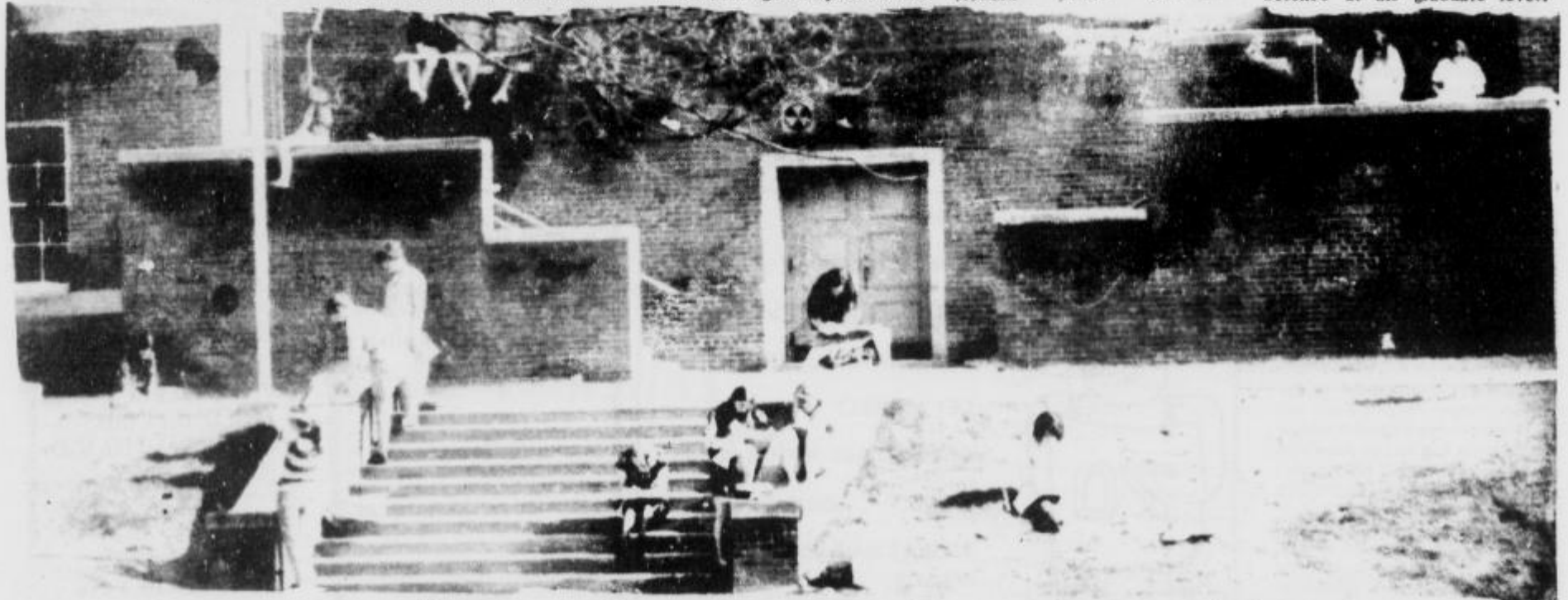
the amendment will go into effect.

Almost all organizations' budgets had been cut previous to the revote and now a review of budget hearings will gain take place. Before the proposal was passed the SCC executive board stated that they would have to cut \$40,000 out of the budget and even with the increased fee they will still have to cut \$18,000 from original budget requests.

Eagles Record Stunning Upset

"What a tremendous team effort!" These words of Coach Jim Dolan sum up Saturday's victory over Slippery Rock by the Lock Haven State track team. The powerful Rockets came out on the short end of an 80-65 score.

Things looked dark for the Eagles when the 440 relay team dropped the baton. At the time of the mishap the Eagles were running stride for stride with the Rockets. The SRSC team won easily after the baton hit the ground.

Race Of The Year

As the results of the field events began to come in, the race of the year started on the track. Four of the top milers in the conference, Ed Grabewski and Randy Deemer of Slippery Rock and Steve Podgajny and Dave Mosebrook of LHS took off at the crack of the gun.

All jockeyed for position for 2 1/4 laps, then Grabewski and Podgajny started to burn. Grabewski took a two-yard lead and held it until ten yards from the finish. In an amazing display of sheer courage, Podgajny made up the two-yard difference and won by inches. Both runners were timed in 4:22.2.

From that point on 'The Rock' was done. Podgajny's unbelievable win seemed to psyche the Eagles tremendously.

The LHS field men outscored the Rockets 32-31 completing seemingly impossible tasks.

McNelis Leads Field Events
Bill McNelis led the field men by winning the triple jump, placing second in the discus and tak-

ing thirds in the high jump and long jump. Don Taylor high jumped 6'2", his best ever, for second place, Bill Kline took second in the shot put with a best throw of 45', Galen Hess took second in the pole vault at 12'6", and Bruce Parkhill and Vic Campagna finished 1-3 in the javelin.

Campagna and Taylor placed second and third in the triple jump, completing a sweep of that event and putting the Eagles to a three point lead with two events to go, the two-mile and the mile relay.

Individual Standouts

Along with Podgajny, Parkhill, and McNelis, other Eagle winners were Tom Ellis in the high hurdles and intermediate hurdles with excellent times of 15.6 and 58.3, Charlie Simcoe with a 50.5 440, tying his stadium record and George Bower with a personal best 1:59 in the 880.

In the two mile run, Podgajny and Mosebrook allowed the Rockets to take the pace for three laps, then ran away from them finishing 1-2, Podgajny completing a fantastic double victory. "Pogo's" two-mile time 9:39 is the best of the year in the conference. Mosebrook ran 9:44, his best ever, and third best in the conference. The Eagles clinched the meet victory, and led by 10 points going into the final event, the mile relay.

Mile Relay Unbelievable

Lock Haven had to have at least six-point lead going into this race because "the Rock" was too tough to beat in the

mile relay. Someone forgot to tell Chris Bower, Carl Klingaman, Charlie Simcoe, and Mike Soyka, because the foursome passed the baton to a victorious 3:30.4, a season's best for the Eagles. The five points picked up here by LHS finalized the score at 80-65.

An amazed and delighted Coach Dolan commented that "Even though my coaching experience is limited to two years, I have never witnessed the team spirit that our men displayed today. When our 440 relay team dropped the baton I thought that might set the tone for the afternoon, but our men came back determined to win"

LHS Sweeps Twinbill From Red Raiders

SHIPPENSBURG--Led by the strong pitching of Gary Hepfer and Jim Sleicher along with timely clutch hitting, the Lock Haven State College baseball team swept both ends of a doubleheader from Shippensburg Saturday, 3-0 and 6-1 upping their season record to 7-4 while winning six of their last seven encounters.

So fine were the two pitching performances that the Red Raiders' only run was unearned and each hurler tossed a four-hitter.

Threatened In Second

The Raiders threatened in the second inning of the opener when Kline led off with a double and advanced to third on a passed ball. He was then picked off third on an alert defensive play by LHS catcher, 'Gentle Ben' John Caione.

Caione had lost the ball for an instant and Kline thinking there was a passed ball started for home when Caione discovered he had been sitting on it, picked up the ball and fired to third nabbing Kline in a rundown.

LHS took a 2-0 lead in the fifth when Hepfer doubled and with two out, scored on Randy Igou's single. Igou then stole second and scored on Denny Rhule's single.

The Eagles added an insurance run in their half of the seventh on consecutive singles by Jim Donahoe and Igou followed by Rhule's double.

Shippensburg threatened in the seventh when they loaded the bases on two walks and a single with two out but Hepfer came out of the jam by getting Polm into a fielder's choice to end the ballgame.

LHS Jumps On Raider Ace

LHS jumped on the ace of the Red Raider staff in the opening frame of the second encounter when Igou started the inning off with a triple.

After Rhule struckout, Don Noblit singled in Igou and went to third on a single by Ray Oberheim. Noblit then scored on a passed ball. Wayne Bacon followed with a single and brother Mike cleared the bases with a booming triple to right that carried close to 375 feet. Bacon then scored on an infield groundout by Doug Conlon.

The Eagles added their final run in the third on a single by Oberheim and an error on the Raider rightfielder, allowing him to advance to second. Mike Bacon then collected his third rbi of the contest when he singled to right.

Sharp After Suspension

Sleicher who had been suspended for five games, looked real sharp and was in trouble only twice during the contest.

With two out in the second the Raiders registered back to back singles but Sleicher came through by getting the next man to groundout.

The only other jam he worked himself into was in the final inn-

ing when Smarrington tripled to right center and scored when Conlon's relay throw to third hit the runner and bounded into the stands with only one out. But after that Sleicher got Deppen to pop out and Sipe on a strikeout giving the Eagles their fifth win in six road contests.

DIAMOND DITTO--The Eagles have already bettered last season's record of 4-9 and they still have six games remaining. Don Noblit continues to lead LHS in hitting with a .371 average. 'Nobbi' slipped 36 points in the contests dropping from .407. In the last five games Denny Rhule has hit an amazing .556 to raise his average from .167 to .333. He also leads the club in innings played and base hits with 14. Randy Igou is the only other regular hitting over .300, sporting a .352 average. He has scored the most runs(12) and is tied with Rhule for the most innings played. Igou also has the distinction of committing the most errors(8). Ray Oberheim has the most rbis with 10. Gary Hepfer

leads in most of the pitching categories having yielded the fewest hits(7), the fewest runs(1), the fewest earned runs(0), the fewest walks(4), the best era(0.00), the best record(2-0) and the best winning percentage(1.000). Jim Sleicher leads in innings pitched with 18 and strikeouts with 10. In total team statistics, the Eagles sport a team batting average of .280 while their opponents sport a .224 average. LHS has outscored the opposition 60-48 and outhit them 92-73. The LHS pitching staff sports an era of 3.90 while the opposition has a 5.22 average. LHS will be back in action today when they travel to Bloomsburg for a doubleheader with the Huskies. The Eagles split an earlier twin bill with the Huskies, dropping the opener, 10-9 and capturing the nightcap 8-3.
