MINUTES

Edinboro University of Pennsylvania Council of Trustees Quarterly Business Meeting Tuesday, June 9, 2015 2:00 p.m.

Crawford Center Conference Room

Prior to the Committee and quarterly, public meeting of the Edinboro University Council of Trustees, Council members conducted their annual review and inspection of facilities. Present for the tour were: Trustees Frampton, Horan, Lowther, Pape, Pulice, Shields and Steele. Vice President Gil Brown and Interim Director of Facilities and Planning Michael Hilbert served as guides. The following areas of the EU campus were visited:

- ❖ Miller Hall building is offline and slated for demolition
- ❖ Baron-Forness Library Master Plan currently in progress
- ❖ Earlley Hall construction to begin this fall to transform aging structure into new home for the Art Department with classroom and studio space
- Centennial Hall remaining offices for the Sociology and English & Philosophy Departments to be relocated this summer to Dearborn Hall

After the group returned to the Crawford Center, Council members met in Committee Meeting with President Wollman and members of the Executive Leadership Team (ELT) beginning at 11 a.m. ELT members present were: Provost Hannan, Vice Presidents Brown and Mengine. Also in attendance at the Committee meeting were: Interim Associate Vice President for Financial Operations Eric Sheppard, Director of Budget and Payroll Theresa Villella, and Dean Scott Miller. The Committee meeting concluded at approximately 12:30 p.m. which was followed by lunch and continued informal conversation. At approximately 1:45 p.m., Vice President Brown and CliftonLarsonAllen audit firm Senior representative Taylor Powell joined the group for a conference call presentation by CliftonLarsonAllen Principal Dave Jacobson. Mr. Jacobson discussed the 2015 Audit Planning process and shared the projected timeline for completion of onsite fieldwork and issuance of all audit deliverables. He stated that the results will be ready for presentation to EU Council members at the December 11 quarterly business meeting. Mr. Jacobson broadly reviewed the audit focus areas and approaches used to conduct the audit (risk-based, assessment and testing of internal controls, and substantive testing). Lastly,

he spoke about a new Governmental Accounting Standards Board (GASB) standard, No. 68 - Accounting and Financial Reporting for Pensions, which is expected to have a significant impact on all of the state universities' financial statements. In Fiscal Year (FY) 2015, the universities will be required to report their share of the pension liabilities of Pennsylvania State School Employees' Retirement System (SERS) and Public School Employees' Retirement System (PSERS) cost-sharing, multiple-employer plans. Prior to this new standard, the University recognized annual pension expense equal to its contractually required contribution to the plans. At the conclusion of the presentation, Mr. Jacobson solicited from Council members any questions or areas of concern.

Hearing no questions or concerns, Chair John Horan thanked Mr. Jacobson and Mr. Powell for the informative presentation and review of the 2015 Audit process to be conducted by representatives from the audit firm of CliftonLarsonAllen.

Chair Horan pronounced that a quorum was in attendance for the official conduct of business by the Council. Chair Horan noted for the record that the proceedings of the Edinboro University

Council of Trustees meetings are recorded. Therefore, public disclosure to those in attendance via his verbal announcement and the written public notice avoids any violation of the Pennsylvania Wire Tapping Act. He then moved to the first order of business - Public Comment. The Chair invited comment from the public in attendance.

Hearing no requests from members of the public to speak, Chair Horan moved on to the next item - Old Business. Chair Horan noted the electronic distribution of the meeting materials. He specifically noted the receipt of Minutes from the Special Meeting held on April 28, 2015, and Minutes of the Quarterly Business meeting held on March 10, 2015. The Chair entertained a motion calling for approval of the Minutes as stated above. <u>It was voted</u>, on motion of Trustee Pulice, seconded by Trustee Higham, to approve the above-referenced minutes as presented. The motion passed with unanimous approval by the Council.

Next, the Chair asked President Wollman to deliver her report to members of the Council of Trustees and public. She began her report by commenting on earlier discussions which took place at the Committee meeting with regard to enrollment. The President stated that while overall enrollment numbers would likely be down slightly for Fall 2015 due to the smaller classes that have been coming through since 2011, the admission statistics project another strong year. Presently, the numbers show an increase of about 10% in new freshman deposits -- freshman who have made a commitment to attend Edinboro University. President Wollman reported that Edinboro University is leading the System with the largest recorded percentage increase to date. There are only three other universities in the System that reported an increase in new freshman deposits, and all three of those universities are located on the eastern side of the state. President Wollman further clarified that Edinboro is the only university in the western part of the state reporting positive increases in terms of number of deposits from new freshman. The EU admissions operation can also boast a 45-55% increase in the number of out-of-state deposits received from new students. President Wollman attributes this increase to not only the success of the first full recruitment cycle of the new tuition pilot program approved by the PASSHE Board of Governors, but also on the impact that Mr. Christopher LaRusso has accomplished during his less than one year of leadership at Edinboro University. In addition, and along with the increase in new freshman deposits, President Wollman stated that the SAT scores for incoming freshman is up about 15 points over last year. Therefore, while Edinboro University is attracting more students, it is also attracting a pool of academically stronger students. It is the goal of admissions staff to not only admit students who can be successful, but also provide access to students who might not have been stellar students in high school, but have great potential. The President congratulated Mr. LaRusso on this impressive accomplishment – a rise in accepted students' SAT scores overall as well as an increased number of deposits. Next, President Wollman spoke about the updated and revised new student orientation program developed by Ms. Fai Howard. Registration for this program is about 50% higher than last year. This is significant since most students do not attend one of these sessions if they do not intend to enroll at the University. In fact, some students are even depositing after they attend the New Student Orientation session. Feedback on the revised program format has been very positive.

The President noted that the University participated, once again, in the Great Colleges to Work For survey. The national average response rate for completion of the survey is 38%. President Wollman reported that Edinboro University's response rate of 48% is significantly higher than the national average which she attributes to employees feeling that it is really important to participate in the process and that the results mean something to the University. The President stated that past survey results have been shared with the campus which produced a number of recommendations that have come forth from a variety of focus groups. Employees appreciate seeing how

recommendations are incorporated and implemented for the betterment of morale and the work environment. One of the outcomes from the focus group sessions was the need and desire for customer service training. Initial customer experience training sessions have been offered and "Constituent Experience" training will be targeted by area to address specific needs. It is important to make certain that employees, students, internal and external constituents have an exemplary experience when they interact with offices across the campus.

President Wollman next talked about the ongoing receipt of new national recognitions and rankings. The President noted the following:

• EU's Animation and Computer Animation programs ranked 17th on the East Coast and 20th nationally among colleges and universities in *Animation Career Review's* 2015 listing of the best animation programs in the United States.

The Game and Virtual World Development track of EU's Computer Science program ranked 15th on its list of Top 25 Public Game Design Schools and Colleges; 17th among the Top 25 Game Design Schools and Colleges on the East Coast; and 48th overall among the Top 50 Game Design Schools and Colleges in the U.S. in the publication's 2015 Game Design and School Rankings.

- EU Counseling program in Top 10
 Best Counseling Degrees website features EU's Master of Education in Educational Psychology program as #6 in the nation in its "Top10 Accredited Online School Counseling Master's Degrees Ranked by Affordability."
- EU Educational Psychology, Art Therapy programs ranked #8
 EU online Masters of Education in Educational Psychology and Master of Arts in
 Counseling: Art Therapy the national's first completely online Art Therapy
 program are ranked #8 in the country in Nonprofit Colleges Online's new Students
 Before Profit Award rankings.

The President thanked Graduate Studies Dean, Dr. Alan Biel, for the quality of Edinboro University's online graduate programming as well as his efforts to ensure well-qualified faculty who are specifically trained to teach online.

President Wollman noted earlier comments by Vice President Tina Mengine during the Committee meeting regarding the University's fundraising results which continue to be on track and are meeting the performance funding targets. Although we have not been provided the final numbers, the University has shown marked improvement this year in Performance Funding measures overall. We have an early indication from the System that Edinboro University will meet the diversity access measures in both Closing the Achievement Gap for Under-Represented Minorities (URM) and Increasing the Graduation Rate for URM and PELL-receiving students. This achievement is significant and credit must be given to a campus-wide focus on retention and graduation. The President noted that this is not only the first time Edinboro University will meet these specific performance targets, but also to have significantly exceeded the targets is very exciting. Previously, we had not been successful in meeting the diversity access measures.

Lastly, President Wollman noted the anticipated receipt of the final report and recommendations from the Blue Ribbon Commission on Campus-Community Safety later this afternoon. Early

receipt of the report has permitted President Wollman to read and review the recommendations. Following the formal presentation of the report to President Wollman by the Commission, she will respond briefly. President Wollman will work to review which recommendations can be implemented and set a timeline for each. The report contained nearly 70 recommendations, and the President expressed appreciation for the Commission's work, feedback and the seriousness with which they addressed the charge. Dr. Wollman confirmed that this was the Commission led by retired judge Michael Palmisano. Attorney Tim George assisted Judge Palmisano as well as members of the Commission in meeting as a whole group and also as smaller subcommittees. They accomplished a great deal of work within a two month period of time. Chair Horan expressed his interest in reviewing the Commission's report.

Under New Business, Chair Horan requested Dr. Michael Hannan, Provost and Vice President for Academic Affairs, to come forward to present on behalf of his division both information and action items. Provost Hannan began with several items contained in the written divisional report (Attachment #1) which had been distributed electronically with other meeting materials. Those entries briefly highlighted included:

• Status - Middle State Commission Accreditation

Edinboro University is in receipt of a report following the visit of a small team dispatched by the Middle States Commission. In the report, Edinboro University was commended for its transparency, the quality of the monitoring report and the seriousness with which the Commission's actions were addressed. Based on a review of the monitoring report and appendices, interviews, and other documents reviewed during the March 31 – April 1, 2015 visit, the team has indicated that Edinboro University meets Standards, 2, 3 and 7 which were the focus of the small team visit. President Wollman expects to receive later in the month formal written notification of the decision to remove the warning based on the positive report by Team visitors.

- Also, the University's Bachelor of Science in Business Administration degree program Financial Services concentration renewed its registration with the Certified Financial Planner Board of Standards, Inc. Edinboro University is one of a limited number of programs that have received that recognition which is very good for the program.
- In terms of faculty recognitions, the following three faculty were recognized at the Academic Honors Convocation on March 17:

Dr. Ken Felker, from Health and Physical Education Faculty member of the Year

Dr. Donald Sheehy from English and Philosophy Scholar of the Year

Dr. Cynthia Legin-Bucell, from Psychology Advisor of the Year

• There are many other faculty recognitions and scholarly activities which are highlighted in the written report. One other mentioned by Provost Hannan was the work and presentation by Dr. Michelle Vitali of the Art department. On April 28, Professor Vitali described her work as a forensic artist in the launch of a new lecture series. Her presentation, "Art as a Forensic Tool: The Case of Embalmed Head," was the inaugural lecture in a speaker series from the Institute for Forensic Sciences. Dr. Vitali presented

- an overview of the ways law enforcement as well as the medico-legal and history communities can use art techniques to help solve cases.
- While there are multiple student recognitions contained in the report. Dr. Hannan highlighted two entries:
 - Allison Gibbens, a first-year graduate student in Speech-Language Pathology, was named to represent all students in the state on the Pennsylvania Speech-Language-Hearing Association's Executive Board. This is quite an honor for one of our students to be selected.
 - Edinboro Biology student, Joseph Mannozzi, was awarded Best Oral Presentation – Biology IV - Mircobiology during a recent conference at Penn State – Erie. Mr. Mannozzi is a senior majoring in Biology, with minors in Psychology and Chemistry, and has been accepted into a Ph.D. program as a fully funded graduate assistant at Louisiana State University in Shreveport. This is just one example of the many great and successful Edinboro University graduate students.
- At the end of this week, Provost Hannan reported that he will receive an award on University's behalf at the American Association of University Administrators (AAUA) Leadership Seminar. The award recognizes the University for its effective and innovative actions in the launch of the Porreco College initiative last year. Dr. Hannan will be given the opportunity to address conference attendees on the background, challenges, and strategies used to establish Porreco College. He also acknowledged the tireless efforts of both Dr. Nathan Ritchey and Ms. Tina Mengine who served to spearhead the project and completed much of the work which resulted in the successful launch of programming.
- Lastly, Ms. Fai Howard, Director of Academic Success and Student Retention, is one of ten individuals selected to be a part of a 2015-17 Class of Emerging Leaders through the National Academic Advising Association (NACADA) program. The program is highly competitive and its purpose is to provide an intentional and focused mentoring experience to members. Ms. Howard will work closely with a mentor to gain skills, experiences, and knowledge needed to move into a leadership position in the Association.

Provost Hannan noted that there were no more information items and that the remaining items were for the Council's action. He noted that there were two separate motions. The first recommendation calls for the approval of a revision to the Bachelor of Science in Health and Physical Education program – Health Promotion concentration. Dr. Hannan reported that recommended revisions were already approved by the University-wide Curriculum Committee and the University Senate in April. <u>It was voted</u>, on motion of Trustee Pulice, seconded by Trustee Shields, to approve the above-referenced motion as presented. The motion passed with unanimous approval by the Council.

Chair Horan requested Provost Hannan to present the second action item. This action item seeks approval by the EU Council of Trustees to move forward for final approval by the Board of Governors of the State System of Higher Education the University's Bachelor of Music in Music Therapy program. **It was voted**, on motion of Trustee Higham, seconded by Trustee Pape, to approve the above-referenced motion as presented. The motion passed with unanimous approval by the Council.

The Chair thanked Provost Hannan for the delivery of information on behalf of his division as well as the action items. Next, under New Business, Chair Horan requested the Vice President for Finance and Administration, Mr. Guilbert Brown, to come forward for the delivery of his report and presentation of action items.

Vice President Brown thanked Chair Horan for the opportunity to provide informational items as well as two action items for the Council's review. The eight-page written report (Attachment #2) can be consulted for further items not highlighted by Vice President Brown. He began with thanks to the many individuals in his division who participated in the development and analyses of items contained in the Monitoring Report submitted to the Middle States Commission. The quality of the report was exceptional as was evident to the visiting team. President Wollman now awaits formal notification by Middle States of the Team's findings and recommended action.

Next, Vice President Brown noted attempts by his area to expand on Edinboro's ongoing efforts to reduce and eliminate the need for paper. He reported the success and transition to an internal electronic budgeting process. The program was developed in-house with electronic spreadsheets placed in a database. The database was then distributed and utilized by over 60 administrative and academic units to produce a consolidated, line item budget. President Wollman, Provost Hannan,

Vice President Brown and the Budget Director are scheduled to meet in the coming week to finalize the first-ever paperless budget process.

Within the Facilities Management and Planning area, Vice President Brown reported that the new interim director, Michael Hilbert, has assumed duties of leadership for that division following the departure of James Miller. He noted that Mr. Hilbert is doing a tremendous job across the board and has poised the area for a launch of a new "zone maintenance" reorganization plan. The Zone Maintenance plan essentially divides the main campus into maintenance zones to be headed by a foreman. This reorganizational plan will increase productivity, lend itself to more efficient supervision of staff, and give staff more pride of ownership within their assigned areas of responsibility. Other projects underway or recently completed include: the boiler replacement project in Compton Hall (moving to a state-of-the-art system which will attain greater efficiencies); start of the Porreco College kitchen and dining space renovation project (to be completed this fall); and issuance of the call for bids – Rose Hall elevator addition (first time for passenger elevator service in that facility).

From the Campus Services area, Vice President Brown noted completed negotiations on an agreement to offer students a BoroBucks program. He stated that it is basically an affinity program whereby students can deposit funds and then use those funds at local business establishments. While the University receives no financial benefit, the program is intended to foster better relationships with the local business community and downtown district. The University anticipates that this program will be a good recruiting tool which will help us to thrive and prosper together.

Vice President Brown next reported on the Council's duty to conduct an annual physical inspection of the facilities in accordance with Act 188. He stated that the required inspection had taken place earlier in the day and indicated that Mr. Michael Hilbert was present if they had any questions relative to the 2015 Facilities Management and Planning Annual Report which had been submitted to them electronically for review. The report includes a detailed list of each building on the main campus as well as the Porreco College campus, the building's condition and also lists deferred maintenance projects. In closing, he noted numerous comments and positive feedback that are consistently received from visitors with regard to the quality of the facilities as well as the general beauty of the campus.

- Contracts and Purchases for period February 1-28, March 1-31, and April 1-30, 2015
- Proposed Fees schedule for 2015-16

Prior to the vote calling for the approval of the Contracts and Purchases, Trustee Shields posed a question regarding an entry on the February 2015 Contracts report. Specifically, he inquired about cost listed for The Advisory Board Company at \$141,000. Both President Wollman and Vice President Brown responded that the cost represents a multi-year membership (three years) covering business and academic components. Their services also include best practice research and practical advice to leaders of academic affairs, business affairs, student affairs, continuing, online, and professional education. Mr. Brown noted that this organization had recently changed its name to Education Advisory Board (EAB). Trustee Shields indicated to President Wollman and Vice President Brown his satisfaction with the response that had been provided to him. It was voted, on motion of Trustee Pulice, seconded by Trustee Higham, to approve the Contracts and Purchases for the periods February, March and April 2015 as submitted electronically. The motion as presented passed with unanimous approval by the Council.

Vice President Brown then sought approval of the proposed Fees schedule for fiscal year 2015-16. He stated that the proposed schedule of fees had been distributed to the Trustees and discussed in detail during the Committee meeting, noting that President Wollman recommends the adoption of the Fees Schedule as presented. Prior to action, Chair Horan requested Vice President Brown to summarize and provide commentary on those fees recommended to change. He commented on the following:

Room & Board

The Room and Board for Edinboro University operated housing and for food plans both are recommended to increase by 3%.

Vehicle Registration – per year

Vehicle registration fee for student parking increases to \$60 from its current level of \$35. Vice President Brown reported that more parking spaces will be available for students as a result of the recommended increase. **Replacement of a Vehicle Registration** increases to \$25 from its current level of \$10.

Course Withdrawal Fee

The fee for a student who withdraws from class(es) after the second week, excluding first semester freshman, increases to \$100 from its current level of \$25.

Library Fines

There is a recommended increase in library fines to 25 cents per book per day from the current level of 15 cents; inter-library loan books at \$1 per day with maximum fine of \$30. **Lost Library Books Fee** – Replacement cost of book plus accumulated fines plus the addition of a \$10 processing fee.

Returned Check

Recommended fee change is an increase in the return check charge to \$30 from the current level of \$20.

Therefore, and based on Vice President Brown explanations provided, Chair Horan entertained a motion calling for the acceptance of President Wollman's recommendation for the approval and adoption of the 2015-16 Student Fees Schedule. <u>It was voted</u>, on motion of Trustee Pulice, seconded by Trustee Pape, to approve and adopt the 2015-16 Student Fees Schedule as presented. (**Attachment #3**) The Chair noted that the motion carried with unanimous approval by the Council of Trustees.

Moving forward to Student Affairs, Chair Horan requested Kim Kennedy, Director for the Office for Students with Disabilities, to come forward for the delivery of the Student Affairs divisional report on behalf of Vice President Sablo who was traveling on business. Ms. Kennedy greeted Council Chair Horan and other members calling to their attention the electronic receipt of a three-page written report (**Attachment #4**). She noted that the report contained not only a number of information items, but also many student accolades. Those entries highlighted by Ms. Kennedy included:

STUDENT SUCESS

- The 26th Annual Scholar-Athlete Honors Banquet recognized 176 student-athletes with a cumulative GPA of 3.00 or higher. Approximately 50% of EU student athletes are scholar athletes.
- Twenty ROTC cadets traveled to IUP to compete for German Armed Forces Proficiency badges. EU cadets earned 16 Gold badges, 3 Silver badges, and 1 Bronze badge. This event involves competition with others in physical abilities, marksmanship, first aid, safety, moral judgment and the ability to put on and take off nuclear and biological protective gear.
- In May 2015, the EU ROTC commissioned eight (8) graduates as Second Lieutenants into eight different areas of military service.
- Three EU Wrestlers (Dave Habat, Mitchell Port and A.J. Schopp, became four-time PSAC Wrestling Champions. Only 14 wrestlers have accomplished this milestone in PSAC history.
- Also, two EU Women basketball players (Laurel Lindsay and Aignee' Freeland) achieved 1,000 point career milestones.

STUDENT DEVELOPMENT

• This year, the Vice President for Student Affairs, Director of the Ghering Health and Wellness Center, and faculty from the Nursing and Communications departments collaborated to conduct focus groups with student parents. This qualitative data, along

with quantitative survey responses, will aid the University in responding better to the needs of pregnant and parenting students. The ultimate goal is to remove barriers to degree completion so that our student parents are able to persist and graduate.

- Residence Life and Housing has fully implemented the online myhousing program to assist with roommate matching and housing compatibility for use by upper level students. The same automated housing software will be used to collect housing deposits and facilitate room assignments for first year students. Also, the software can be used to simplify student disciplinary proceedings through automatic letter generation, electronic file management, and report generational capabilities.
- Ten (10) undergraduate and graduate Resident Life and Housing staff members attended the Mid-Atlantic College and University Housing Officers Student Staff Conference. Also, seven (7) Residence Hall Association student leaders attended the National Association of College and University Residence Halls (NACURH) Leadership Conference held at North Dakota State University.
- Students with physical disabilities went tubing at Mount Pleasant. The OSD students were paired with students from the EU adaptive health and physical education program. Also, a fabricator from the Grove City area showcased equipment produced by *Trac-Fab*. They demonstrated an all-terrain TracFab tracked wheelchair which provides the disabled community options to improve their mobility in places where a standard wheelchair or power scooter cannot go. This product provides individuals with access to the outdoors and related activities (fishing, hunting, enjoying a day at the beach). This equipment was initially designed in concert with EU alum Joe Shrader from Cambridge Springs. It allowed him to hunt and fish, but also showed students how independence can be increased through technologies.

COMMUNITY SERVICE and OUTREACH

- As the result of effort put forth by members of the Student-Athlete Advisory Committee (SAAC) and by the Health and Physical Education and Communication Studies departments, over \$10,700 has been raised for Make-A-Wish. It is significant to note that Edinboro University led all PSAC institutions and was third in the nation overall in Division II in support of this initiative.
- The University Programming Board (UPB) sold out their spring concert Mac Miller. For those not familiar with the name and genre of music, Mac Miller is a popular rapper from the Pittsburgh area.
- At the end of May, the 11th Annual Edinboro Sports Memorabilia Auction was held at the Ambassador Hotel. Pittsburgh Steelers offensive lineman, Mike Pouncey, was the guest signer and former hockey standout Mike Rupp served as the Master of Ceremonies.

STAFF ACCOLADES and INITIATIVES

- Ms. Kennedy shared the following coaching accolades:
 - O Head Wrestling Coach Tim Flynn was named the Eastern Wrestling League (EWL) Coach of the Year for the second straight year. He was also was chosen as Edinboro University's Coach of the Year for the second consecutive year.
- Dr. Amy Franklin-Craft, Residence Life and Housing, was elected to the governing board of the American College Personnel Association.
- Vice President for Student Affairs, Dr. Kahan Sablo, was elected to the General McLane School Board of Directors.

ATHLETIC UDPATES

- Wrestling Team The Wrestling Team had a highly successful season. Edinboro University sent six wrestlers to Nationals and the Team placed third overall; it was the best finish in the school's history.
- Wheelchair Basketball Team Two Edinboro University team members (Mike Adams and Derek Strickland) received All-American honors which is not only evidence of the growth and strength of that program, but also their performance academically.
- **Men's Tennis Team** The Team won its second straight PSAC Championship to qualify for the NCAA Division II Atlantic Regional competition.

The last report to be made to members of the Council was a report presented by Edinboro University Vice President for University Advancement Tina Mengine. Ms. Mengine noted the electronic distribution of the full report (**Attachment #5**) of which she highlighted the following:

DEVELOPMENT

- Year-to-date fundraising total stands at \$3,475,046. Specifically, Vice President Mengine stated that was approximately \$1.1 million ahead of last year's figure. The fundraising team continues to perform at a high level with the month of April being the largest fundraising month in history, closely followed by the month of May which has been the second largest in University history.
- Nine (9) large gifts, ranging from \$10,000 to \$100,000, were received by the University Advancement office this past quarter.
- Eight (8) new scholarship funds were created and established.
- Preparation and planning is underway for the University's largest single fundraiser in support of the Porreco College initiative. The second Gala in the Orchard will be held on Saturday, July 18. To date, \$121,000 has been secured from hosts for the event. Vice President Mengine reported that tickets will be mailed in the coming week.

ALUMNI RELATIONS

- Vice President Mengine noted the election of new officers by the Alumni Association.
 - Scott Irlbacher President
 Brian Arrowsmith, Vice President
 Dave Niemira, Treasurer
 Susan Crandall, Secretary

MARKETING and COMMUNICATIONS

- The primary focus of the marketing area continues to be undergraduate Admissions.
- The Marketing staff continues production of several multi-media advertising campaigns and commercials.
- Marketing and Communications' year-long online advertising campaign boasts 8.5 million impressions.
- Vice President Mengine stated that the online and traditional media exposure has been very aggressive which she believes is a big part of the success experienced by the Admissions office.

MEDIA

- Public relations efforts also continue to be aggressive with more than 44 television stories airing about Edinboro University this past quarter.
- More than 150 local newspaper articles were printed about Edinboro University this past quarter.
- More than 46 stories and/or mentions of Edinboro University were made in the extended tri-state area as well as in national media.

A full summary of EU in the News can be found on pages 5-20 of the written report.

SOCIAL MEDIA

• Continues to grow in all areas, and we have added InstaGram.

Following Vice President Mengine's summary, Chair Horan sought feedback and questions. Trustee Chaffee asked about the practice of seeking gifts from University employees in support of other nonprofit agencies (e.g. United Way Campaign). President Wollman and Vice President Mengine noted that Edinboro University does participate in the United Way's State Employee Combined Appeal (SECA) whereby our faculty and staff pledge to a campaign which supports an external community agency. Trustee Chaffee reported that an unnamed local university would permit only the conduct of an internal Capital Campaign on their campus. She inquired about the University's past practice in this regard or if there was policy in place that prohibit this type of fundraising. Ms. Mengine noted that while Edinboro University does conduct an annual staff campaign, it too supports the work of the United Way. University employees are presented with an array of options and, for the first time last year, an employee could opt to direct the contribution to the EU Foundation. Ms. Mengine stated that a fair amount of employees do participate, but that the largest portion represented in terms of participation are from custodial/facilities and staff members. President Wollman added from her perspective, and all may not agree, that there is an appropriate role for the University to show its support of the community. She feels that both can be accomplished - encourage people to support their community and to also support to the University. Trustee Lowther asked about the percentage of University employees who support and give back to the University. Vice President Mengine stated that she did not have that number readily available, but thought it to be around 30%. President Wollman noted that we are moving to attain and increase the number to be more in line with the national average of 30-40%. The President further stated that giving back in support of the University has generally not been a part of the culture. Ms. Mengine reiterated that we are making slow progress in terms of cultural change relative to expectations for support.

Lastly, and for the record and the Council's information, Vice President Mengine reported that a list of gifts-in-kind received since the last business meeting of the Council held on March 10, 2015, had been electronically distributed with the meeting materials. The five-page report was quite extensive this time due to the recording of gifts solicited in support of the 2015 Curly Halmi Game Dinner and Scholarship event and the Sports Memorabilia Auction to be held in May 2015. See **Attachment #6**.

Chair Horan thanked Ms. Mengine for her brief, but in-depth report. Next, under Executive Reports, the Chair invited Trustees Pape and Lowther to present the recommendation of the Nominations Committee. These Trustees were appointed by outgoing Chair to develop and recommend a slate of officers (Chair, Vice Chair and Secretary) since the office terms of Trustees Horan, Frampton and Pulice were to expire at the end of the month (June 30, 2015). Trustee Pape

stated that she and Trustee Lowther had spoken several times about the process they would undertake in the identification of a slate. Each held a conversation with potential slate candidates to make certain that the Trustee had the ability and also the willingness to give of their time to serve in the capacities requested. As a result of these conversations, Trustee Pape presented the following slate in the form of a motion:

Dennis Frampton Chair
Barbara Chaffee Vice Chair
Daniel Higham Secretary

Prior to the vote, Chair Horan sought discussion on the slate as presented by Trustees Pape and Lowther and asked if there were other nominations from the floor. Hearing no requests for further discussion or additional nominations, the Chair pronounced the nomination slate closed. **It was voted**, on motion of Trustee Pape, seconded by Trustees Pulice and Shields, that the above referenced slate becomes the Elected slate. The motion carried with unanimous approval by the Council. Chair Horan congratulated the elected officers and a round of applause followed.

Next, Chair Horan asked President Wollman to review and comment on the proposed Edinboro University Council of Trustees 2015-16 Schedule of Meetings as presented. The President stated that Trustees should have in front of them a revised schedule, noting that changes were made to this document based on earlier conservation. Trustees should note that these revisions to the schedule were to better align the timing of meetings with the overall work of the Council; thus, eliminating the need to call for as many Special meetings throughout the academic year. Changes included: holding public quarterly business meeting on the Friday prior to Commencement and placement of a quarterly meeting during the month of July since often times a Special Meeting has been needed for the approval of the University's fiscal year budget. President Wollman invited additional comment. Hearing none, Chair Horan entertained a motion calling for adoption of the revised Edinboro University Council of Trustees 2015-16 Schedule of Meetings as presented. It was voted, on motion of Trustee Chaffee, seconded by Trustee Frampton, to adopt the 2015-16 Schedule of Meetings as presented (Attachment #7). The above-motion carried with unanimous approval.

The Chair asked Trustee Shields to deliver his report as a member of the PACT Executive Committee. He noted that he will be serving as the Interim PACT Chair for the coming year. In his capacity as Interim Chair, Trustee Shields will convene a meeting in Harrisburg on July 29. Trustee Shields encouraged newly elected Chair Dennis Frampton and outgoing Chair John Horan to attend the July 29 meeting. In addition to PACT Executive Committee members, the Chancellor and Board of Governors Chair Guido Pichini will be in attendance and Trustee Shields reported that he has invited all PASSHE Council Chairs to attend as well. The purpose of the meeting will primarily focus on planning for the fall conference, upcoming spring conference as well as discuss a number of other items. Specifically under consideration by the PACT leadership is the hosting of the Fall PACT conference in conjunction with the meeting of the Association of Governing Boards (AGB) of Universities and Colleges slated to be held in Philadelphia November 8-9, 2015. Trustee Shields plans to increase attendance by Council members at PACT meetings, noting that attendance has been steadily declining over the last 10-12 years. President Wollman added that she thought meeting with the AGB was an excellent idea and that there would be great value added to one's attendance at a national, quality meeting designed to enhance and provide professional development opportunities. Trustee Shields thanked President Wollman for her endorsement of this concept. He noted that one of items under consideration would be the increased cost of the trip and it would be Trustee Shields' hope that the individual universities

would absorb some of the travel/conference costs. Lastly, he also encouraged Council members, particularly newer Trustees, to review the recently revised and published PACT Handbook for Trustees of Universities of the Pennsylvania State System of Higher Education. One of Trustee Shields' goals as interim chair is to create greater levels of engagement with Trustees as well as to increase involvement and participation by member Trustees inside the organization. Trustee Shields noted that during the budget hearings, negotiations and debate among members of the House and Senate, it is of the utmost importance for all Trustees to be supportive of PASSHE's Appropriations request.

Chair Horan thanked Trustee Shields for his report on behalf of the PACT Executive Committee. He asked if there were any other items of business to come before the Council. Hearing no requests for further discussion, the Chair entertained a non-debatable motion calling for the adjournment of the business meeting. <u>It was voted</u> by Council members in attendance to adjourn the June 9 business meeting. The business meeting officially adjourned at 3:14 p.m.

Academic Affairs Report – Report Edinboro University Council of Trustees June 9, 2015

Accreditations and Recognitions

- On April 20, 2015, the **Middle States Commission** provided a report after the follow-up visit on March 31-April 1, 2015, which commended Edinboro University for its transparency, the quality of the monitoring report and the seriousness with which the Commission's actions were addressed. Based on a review of the monitoring report and appendices, interviews, and other documents reviewed during the visit, the team indicated that **Edinboro University meets standards 2, 3, and 7,** which were the focus of the small team visit. The Commission will make its final determination in June.
- The University's Bachelor of Science in Business Administration/Financial Services program has been approved for renewal registration by the Certified Financial Planner Board of Standards, Inc.

Academic Program Initiatives

- On May 5, 2015, President Wollman reported that Edinboro University's online Art Therapy program was just rated as the #7 Online Counseling program in the nation by Best Master's in Psychology! This program was also previously recognized with Nonprofit Colleges Online "Students Before Profits Award." Congratulations to the program faculty, especially Dr. Penny Orr and Dr. Adrienne Dixon, and the academic leaders who have worked very hard to ensure unbeatable quality and value in this highly-regarded degree.
- On May 7, 2015, President Wollman reported that **Edinboro University's** renowned programs in animation have again been ranked among the very best in the country by **Animation Career Review** in its annual listing of the best animation programs in the US. EU's animation and computer animation programs are ranked **17th on the East Coast** among public colleges and universities and **20th nationally**. This is an even higher ranking than last year. Congratulations to our **Art Department and, especially, our stellar Animation faculty!**
- On April 9, 2015, a cohort of 29 honors students from the Dr. Robert C. Weber Honors Program departed for Washington, DC, for the Honors Program Spring trip. The students were joined by Dr. Marc Sylvester (Interim Director) and Dr. Jean Jones (Director), who was on sabbatical spring semester. Finance and Administration – Report Edinboro University Council of Trustees June 9, 2015

Office of Finance and Administration

Working with Provost Hannan to develop the University's monitoring report to the Middle States Commission for Higher Education (MSCHE) including over 40 detailed exhibits was the primary focus of Finance and Administration's efforts during the third quarter of FY 2015. Building from financial plans to address the current year deficit and the long-range financial strategy presented to the Council of Trustees in December 2014, new administrative processes to support budget allocations, strategic enrollment management, and program assessment were designed and implemented during this period. The MSCHE visiting team identified these initiatives as among the many changes instituted by the University to fully meet the accreditation standards under review. Visiting team members expressed that Edinboro University's progress serves as a model of transformation for other higher education institutions and issued commendations for EU's transparency in discussing financial issues and for the quality of the submitted monitoring report.

Budget

The University started the 2015-2016 Budget process in late April. A new process to develop a budget was introduced to the campus called, Boro Budget. This software allows financial managers to complete their budgets without the use of paper. During the last week of April, training sessions were conducted for all financial managers who are responsible for submitting budgets. Up to 70 financial managers were trained. The training and software were well received and comments were made that it was the best training they had ever received on campus. Financial managers embraced the paperless process.

Prior to Boro Budget Training, Business Intelligence training was also provided to financial managers in late March. Forty employees attended.

Enterprise Systems

Between March 1 and May 18, 2015, the Enterprise Systems Team (EST) closed 259 Tech Help Tickets and processed 56 Employee Changes and Relocation requests. In support of Admissions and Retention, EST successfully launched the University's New Student Orientation sign-up methodology using our new web forms product. Working towards a paperless campus initiative, our developers completed web forms training class with a new Tuition Waiver process to be the first large project using this new toolset. Faculty evaluation results were also moved onto an online format.

Of utmost concern for any organization is security. EU's email spam device from March thru May 13 blocked 957,289 spam messages and stopped 4,835 messages that contained viruses out of a total of 2,550,274 incoming messages. Servers were updated to ensure Edinboro University has the latest protection including the latest patch sets, operating systems, and updated secure certificates. We are decommissioning older servers by increasing our virtual environment causing reductions in our operational footprint and expenses.

As the summer months approach, we are looking at several improvements, some of which include regulatory release upgrades for Banner including the new XE modules, authentication

changes in Office 365 for students and Banner/SCOTS, Business Intelligence enhancements, Oracle and SQL Server database upgrades, attaining security certifications, and web site/portal/mobile upgrades and modifications. An immense project scheduled for this summer affecting all faculty and staff will be upgrades to our Exchange email application and servers. Summer promises to be a very demanding time for the Enterprise Systems staff.

Facilities Management and Planning

- With the departure of Jim Miller in mid-March, Michael Hilbert, Manager of Capital Projects and Energy, has assumed the role as Interim Director of Facilities Management and Planning which has helped the department to continue its course nearly seamlessly.
- Ashley Spears, former EU Construction Project Manager, has accepted an offer and will return to the University as Manager of Capital Projects in June. Ashley's wide range of experience in construction management not only with the University but elsewhere will ensure the on-time completion and quality of current and future projects.
- Facilities is poised to launch a new "Zone Maintenance" reorganizational plan which will increase productivity, lend itself to more efficient supervision of staff, and give the maintenance staff more pride of ownership in their assigned buildings.
- The Compton Hall boiler replacement project is complete, providing a state of the art hot water boiler system which will attain efficiencies as high as 98 percent.
- The Porreco College kitchen and dining space renovation project has been awarded and construction will commence during the summer.
- The Rose Hall Elevator Addition bids are projected in late May and construction will begin in the fall with an anticipated completion of August of 2016.
- The final design for the renovation of Earlley Hall into classroom space for the Art Department in nearly complete. The project is slated for construction in Fall of 2015 with an anticipated completion of August 2016.
- Desmone Architects are nearing completion of the Master Plan for the Baron-Forness Library which will provide the initial vision for future renovation of the Library and addition of a new dining facility which will overlook Mallory Lake. The Master Plan will include a centralized home for many student services such as Student Success and Career Services.

General Accounting (includes Bursar, Cash Management and Accounts Payable)

- Continuing to work with Budget Director and Controller to achieve "soft close" of financial activity. This is now a monthly process that includes an updated year-end forecast for senior management and Council of Trustees.
- Design and testing of the SAP Travel Management module is currently underway.
- Promoted Michelle Taylor from the Bursar's Office and transferred to the Accounting Department. This move will provide needed depth and the opportunity to accomplish more tasks in a timely manner.

Goals

- Participate in the re-creation of a sponsored research administration role at Edinboro University.
- Go live with Travel Management module.
- Review, revise and create new institutional policies and procedures as deemed necessary.

- Aggressively work towards paying more Edinboro vendors via ACH or other automated means versus the 80% now paid by check and snail mail.
- Work with Technology and Communications to automate some manual interfaces between the Bursar's Office, Financial Aid and the Registrar.

Campus Services (Auxiliary Enterprises)

- The "Boro Bucks" program, which allows students, faculty and staff to create a declining balance account on their existing Edinboro ID / Meal Plan cards, is in the initial stages of implementation. The program will be fully in place by the beginning of the Fall 2015 semester.
- Additionally, we have decided to no longer force our student body to surrender remaining
 flex dollars associated with their meal plans or engage everyone in a year end "Flex
 Frenzy" designed to direct remaining flex balances to products sold by Chartwells. We
 are one of few universities that have made such a decision and may be the only PASSHE
 school at this point in time.

Purchasing and Contracts

- The Purchasing Office has furniture, fixtures and equipment orders that are still being processed for the Ross Hall project. The balance left on this project is \$63,196.
- Service contracts have been awarded for various projects including dome maintenance, preventive maintenance of the JCI (Johnson Controls Inc.) Metasys Systems, Crawford Center pump installation, Compton boiler replacement, backflow preventer testing, and fire damage restoration work at the Pogue Student Center and installation of Real Time Automation Controller (RTAC) in the substation. New projects in the bid process now are for the Porreco kitchen renovations and Rose Hall elevator installation. We will soon be bidding out the Loveland Hall stairs replacement.
- Other agreements The Purchasing Office has fully executed multiple agreements including agreements with Starfish Retention Solutions; Verizon for fiber relocation; and Affiliation Agreements with Rehab Hospital of Indiana and Kindred Rehab Care, among many others. The Purchasing Office has also processed multiple agreements for legal review and approval including the agreement with CBORD for the Boro Bucks program.
- Ongoing management of the Xerox managed print services contract.
- Staff development Representatives from the Purchasing Office took part in an Information Technology and Procurement meeting with the Western Schools hosted by Edinboro on February 17, 2015. The purpose of the meeting was to discuss issues that face both areas and to work on them collaboratively. The Purchasing Office also attended the Spring Procurement Conference from April 22-23, 2015, where various ideas and topics were discussed.

Institutional Research (IR) at Edinboro has been busy living up to its new, defined mission: "It is the mission of the Office of Institutional Research and Assessment to collect, analyze, maintain, and disseminate official institutional data, and to provide official institutional information to both internal and external constituents for the purposes of describing, documenting, and publishing institutional information and measuring effectiveness."

Work over the past several months includes:

- Preparing portions of the Middle States Monitoring Report, specifically the piece on Institutional Effectiveness as well as future enrollment projections for budgeting.
- Tracking and updating Edinboro's Strategic Plan through the further development of the scorecard.
- Updating and working with leadership on PASSHE Performance Funding, interacting with the state on requested measures.
- Ensuring that Edinboro is up to date on its PASSHE reporting.
- Performing numerous internal surveys for staff and external surveys mostly for publication.
- Working with the Vice President for Finance and Administration to specify the role of Institutional Research at Edinboro and its development in the future.
- Analyzing and assessing data integrity and finding solutions to known issues.
- Co-chairing the Institutional Effectiveness Committee and administering its monthly meetings, requiring the reporting of new topics and presentations each month.
- Working with a team on a Federal Department of Education grant that looks to improve student retention and graduation outcomes at the institution.

Networks and Telecommunications

Telecom system improvements:

- Re-route of Verizon fiber into University manhole and duct bank system. Old fiber route was vulnerable to being dug up and also tied to abandoned pedestrian bridge which is disintegrating. Fiber contains circuits for University's voice services and cellular towers.

- Configured backup voice gateway switch. It will be fully tested during switchgear weekend. Business Continuity in the event of failure of the primary voice gateway switch.
- Installed monitoring software for VoIP system equipment.
- Installed software and put UPS units in wiring centers on the network for remote monitoring.

Network improvements:

- Due to existing firewalls reaching capacity limits researched "next gen" firewalls which also include built-in intrusion detection and prevention. Determined best fit for University and completed proof of concept for Palo Alto Firewall/Intrusion Detection/Prevention device. Purchase and implementation planning and preparation in progress. In addition to firewall capabilities, device will provide assistance in reducing risk by identifying/reducing security threats and preventing cyber-attacks.
- Palo Alto evaluation unit helped to review and identify existing firewall risks. Action taken to mitigate those risks.
- Palo Alto evaluation unit used to identify servers and pcs with vulnerabilities, viruses and malware. Information provided to responsible parties for system scanning and remediation.
- Researched solutions to address the Highlands Wi-Fi deficiencies due to outdated design and Wi-Fi equipment to meet student demand and expectations. Put together in-house and outsourced options for addressing the service issues and presented to Foundation Board.
- Replaced Dearborn building aggregator network switch with modern refurbished switch.
- Worked with WFSE (campus radio station) to get their new equipment networked.
- Worked with PASSHE Network Operations Center to improve their emergency backup connectivity.

Additionally, she is a part of the Law Enforcement and Code of Conduct Working Group and working on formatting an MOU with the Edinboro Police Department to address the issues of sharing information.
- Continued work with Emergency Response Team Operational Group to develop emergency plans and completing emergency preparedness projects.
- "The First Three Minutes" training was conducted by Lt. Kraus for the City of Erie SWAT team.
- K-9 Officers conducted several high school locker searches and conducted community outreach by presenting to school-age children.
- Continued coordination with the District Attorney's Drug Task Force to identify suspected drug activity in this area.
- Re-structuring of the police department and additional responsibilities of supervisors for better efficiency of resources.

Student Affairs – Report Edinboro University Council of Trustees June 9, 2015

STUDENT SUCCESS

- The Athletic department held its 26th Annual Scholar-Athlete Honors Banquet, honoring 176 student-athletes with a cumulative GPA of 3.00 or higher. Approximately 50% of our student athletes are scholar athletes.
- Twenty ROTC Cadets traveled to Indiana University of Pennsylvania to compete for German Armed Forces Proficiency Badges. Our cadets earned sixteen gold badges, three silver badges, and one bronze badge as a result of outstanding performance.
- ROTC commissioned eight graduates as second lieutenants into various facets of military service.
- Dave Habat, Mitchell Port, and A.J. Schopp became four-time PSAC wrestling champions. Only 14 wrestlers have previously accomplished this milestone in all of PSAC history.
- Laurel Lindsay and Aignee' Freeland both scored their 1,000th career point during our most recent basketball season. Lindsay became the third player in PSAC history with 1,000 career points, 500 career rebounds and 500 career-assists.

STUDENT DEVELOPMENT

- The Vice President for Student Affairs, Director of the Ghering Health and Wellness Center, and faculty from the Nursing and Communications departments collaborated to conduct focus groups with student parents. This qualitative data, along with quantitative survey responses, will aid the University in better responding to the needs of pregnant and parenting students. The ultimate goal is to remove barriers to degree completion so that our student parents are able to persist and graduate.
- The Ghering Health and Wellness Center hosted its 17th Annual Health Fair, with approximately 65 community vendors providing health-related information to over 618 participants.
- To assist with roommate and housing compatibility, Residence Life and Housing will utilize automated housing software to collect housing deposits and facilitate room assignments for first year students. This same software simplifies student disciplinary proceedings through automatic letter generation, electronic file management, and report generation capabilities.
- The Peer Educators and members of the Student Health and Wellness Center Advisory Board (SHWAB) conducted presentations on sexual assault bystander intervention for student athletes, fraternities, sororities and ROTC. In addition, SHWAB and the Peer Educators conducted educational events for Safe Spring Break Week, Cervical Cancer Awareness Week, and Sexual Responsibility Week.
- Students with physical disabilities went tubing at Mount Pleasant, where *Trac-Fab* showcased various all-terrain mobility devices that can assist with student independence in inclement climates.
- Ten undergraduate and graduate Residence Life and Housing staff members attended the Mid-Atlantic College and University Housing Officers Student Staff Conference. Also, seven Residence Hall Association student leaders attended the National Association of College and University Residence Halls Leadership Conference held at North Dakota State University.

COMMUNITY SERVICE AND OUTREACH

- Athletics held its Annual Student-Athlete Auction, with over 300 people in attendance. Approximately \$2,800 was raised for Make-A-Wish through the auctioning of student-athletes. Due to the effort put forth by members of the Student-Athlete Advisory Committee (SAAC) and by the Health & Physical Education and Communication Studies Departments, over \$10,000 has been raised this year. Edinboro University led all PSAC institutions and was third in Division II with over \$10,700 raised.
- The University Programming Board (UPB) sold out their spring "Mac Miller" concert. Approximately 2,700 tickets were sold.
- The 11th Annual Edinboro Sports Memorabilia Auction was held at the Ambassador Hotel.
 Pittsburgh Steelers offensive lineman Maurkice Pouncey was the guest signer, and former hockey standpoint Mike Rupp served as the master of ceremonies.

STAFF ACCOLADES AND INITIATIVES

- Head Tennis Coach Lee Underwood was named the PSAC Men's Tennis Coach of the Year for the second straight year.
- Softball Head Coach Dan Gierlak earned his 400th career win.
- Head Wrestling Coach Tim Flynn now has 37 All-Americans in his 18 seasons. He has led Edinboro University to five top ten finishes at Nationals and 12 top 20 finishes.
- Also, Head Wrestling Coach Tim Flynn was named the Eastern Wrestling League (EWL) Coach of the Year for the second straight year and seventh time overall. He was selected as the PSAC Coach of the Year for the 13th time. In addition, he was chosen to be Edinboro University's Coach of the Year for the second consecutive year.
- Dr. Amy Franklin-Craft was elected to the governing board of the American College Personnel Association.
- Dr. Kahan Sablo was elected to the General McLane School Board of Directors.

ATHLETIC UPDATES

Wrestling -- The wrestling team sent six wrestlers to Nationals and placed third overall - the best finish in school's history. The Fighting Scots Wrestling team had four All-Americans for the second time in school history.

Women's Basketball -- The Fighting Scots finished with a 20-8 record, giving them a 125-27 record over the last five years. Edinboro qualified for the PSAC Tournament for the sixth straight year and 11th time in the last 12 years. Laurel Lindsay earned WBCA (Women's Basketball Coaches Association) honorable mention All-American honors for the second straight year and was also a Division II Bulletin honorable mention All-American. Lindsay was also named Edinboro's Nancy Acker Award recipient as the Senior Female Athlete of the Year.

Men's Basketball -- Finished with a 14-13 record during Pat Cleary's second year as head coach. The Fighting Scots made the PSAC playoffs as the number five seed after being picked to finish eighth in the PSAC coaches' poll. Henri Wade-Chatman earned first team All-PSAC West accolades and Jaymon Mason was selected as the PSAC West Freshman of the Year.

-3-Student Affairs – Report June 9, 2015

Men's Swimming -- Edinboro finished seventh at the PSAC Championships. Micah Cattell was named the PSAC Men's Swimming Champion Scholar. Tony Romanini took first place in the All-PSAC 200-yard backstroke and second place for the 100-yard backstroke.

Women's Swimming -- Edinboro ended the year with a 4-3 record, defeating Clarion for the second straight year. The Fighting Scots finished seventh out of 13 teams at the PSAC Championships. Staci Schrecongost competed in three events at the NCAA Division II National Championships, earning All-American honors in two events. She finished seventh in the 200-yard freestyle, then earned honorable mention All-American honors with a 15th place showing in the 500-yard freestyle.

These Fighting Scots were recognized as a College Swimming Coaches Association of America (CSCAA) Fall Team Scholar All-America Team. The women's team ended in 24th place with a 3.32 GPA.

Wheelchair Basketball -- The Wheelchair Basketball Team finished sixth at the 38th Annual National Intercollegiate Wheelchair Basketball Tournament with a 15-22 record. Mike Adams earned second team All-American honors, just the fourth Edinboro player to earn All-American honors as a sophomore. Derek Strickland earned NWBA (National Wheelchair Basketball Association) All-Academic honors for the second straight year and is the third Fighting Scot to be recognized twice.

Men's Tennis -- The Men's Tennis team won its second straight PSAC championship to qualify for the NCAA Division II Atlantic Regional for the second straight year. Bruno Borja and Brandon Romain won the PSAC Doubles championship in the fall. Vitor Albanese was named the PSAC Men's Tennis Athlete of the Year, and was also selected the PSAC Freshman of the Year. Albanese was also named the ITA Atlantic Region Rookie of the Year.

Women's Tennis -- Edinboro finished the year with a 7-11 record.

Softball -- The Fighting Scots tied for the second-most wins in school's history. Laura Crooks was named to the All-PSAC West first team and Kalet Lenart was a second team selection. Crooks was also a second team Daktronics/Division II CCA All-Atlantic Region selection.

Women's Indoor Track and Field -- Brianne Dietrich earned All-American honors in the long jump at the NCAA Indoor Track & Field Championships, finishing eighth. Edinboro finished fifth out of 16 teams at the 2015 PSAC Indoor Track & Field Championships.

Men's Outdoor Track and Field -- Edinboro finished 9th out of 14 teams at 2015 PSAC Outdoor Track & Field Championships.

Women's Lacrosse -- Finished with a 6-9 record, after launching with a 6-1 start, the best in school history. Injuries hampered the team during the final stretch, and five of the nine losses came to nationally-ranked teams.
