**EDINBORO RESIDENCE HALLS GETTING STATE-OF-THE-ART  
COMMUNICATIONS NETWORK**

The residence halls at Edinboro University of Pennsylvania will receive a multimillion-dollar upgrade this summer to give students a state-of-the-art communications network. Officials at Edinboro and Williams Communications Solutions, the company overseeing the project, said each residence hall room is being wired for digital cable television services, two high-speed data connections, and a new telephone system.

“The result of all these improvements will be one of the most advanced technological environments at any university in the nation,” said Edinboro President Frank G. Pogue. “We are taking these steps to ensure that our students have the best facilities and services we can possibly provide.”

In the past, students living on campus could only access the Internet from their rooms by using a modem and the phone line. By the time classes resume in the fall, each room will have two data lines with 10 to 100 megabits per second transfer rates – some of the highest speeds available. This significant improvement in speed will allow students to move data, graphics and video almost instantaneously within the campus network, and provide high-speed access to the Internet.

The satellite cable television system will bring more than 50 cable channels directly to each room, including all major networks, numerous educational channels, and three HBO channels.

All of the campus, including most faculty and administration offices, will have a new telephone service. The voice communication system will offer students a variety of advanced features including caller ID, call waiting, call forwarding, speed dialing, and three-way conferencing.

Helping to ease the transition to the new communications network will be a technology service center where students will be able to purchase "Edinboro ready" computers equipped to access the new data system. Students will also be able to have their personal computers upgraded or repaired, buy accessories and software, and sign up for wireless phone service.

"Woman II, Scent Bottle," designed by Edinboro University of Pennsylvania art professor Sue Amendolara, has been selected for the permanent collection at the Smithsonian Institution's Renwick Gallery of the National Museum of American Art in Washington, D.C. The gallery is committed to the collection, exhibition, study and preservation of decorative arts and crafts from early American to present. It features one-of-a-kind pieces created from clay, fiber, glass, metal and wood.

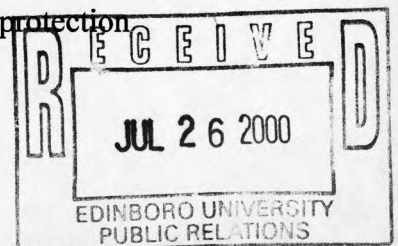
Amendolara received her bachelor of fine arts degree from Miami University and master of fine arts degree from Indiana University. She began teaching jewelry design/metalsmithing at Edinboro University in 1991.

Inspired by nature, Amendolara combines precious materials to make jewelry and functional holloware that have a sense of beauty, grace and elegance. She selects materials that complement each other in color, texture and surface with sterling silver being the predominate material accentuated by coral, 18K gold and 24K gold foil.

"I am inspired by plant forms and have used them directly in my metalwork since 1993 after I traveled to the primary rain forest of Ecuador where I was introduced to several exotic plants," said Amendolara. She is specifically drawn to the heliconia for its graceful curving bracts in alternating patterns along a thick stem. The heliconia is a strong plant, yet it bares an elegant and graceful gesture. Amendolara finds this contrast compelling.

"After the birth of my first child," Amendolara said, "my work began to take on a maternal quality." Still using plant forms as imagery in her work, the ideas of protection

and growth are now evident. Metal forms are used to surround and shelter small objects while growth is shown through floral offshoots.

Among Amendolara's honors are the 1994 and 1999 Pennsylvania Council on the Arts Fellowships, 1995 Mid-Atlantic Regional/NEA individual fellowship. Her work has been displayed in the American Craft Museum in New York City and the Musée Nationale Suisse in Zurich.
