 - Cutting winter break to 4 weeks and having a winter intersession built into that 3 ½ weeks and offer those credit courses adapted to be done in 3 ½ weeks with out a struggle to students and faculty which will be parallel to Summer intersession 1.
 - Having a three-day weekend for Martin Luther King Jr. day. If we shorten the calendar in any way they would be shortening the spring semester. Is there any history of taking Good Friday off and go for Easter to spend time with family? Stopped doing that across the state system. The only red flag is that there needs to be 75 instructional days including final exams.
 - There can also be reading days built in during finals week so there are two days of finals and then one day with no finals and then an additional two days of finals.

- Possibly include spring break as an Easter break as well. Use this with caution because spring break can be floating very early or very late.
- Spring break being April 1st or April 7th.
