VIII. Standing Committee Reports

A. Appropriations Committee - Treasurer Zavinski

1. The Clarion Call has submitted seven supplemental requests to be reviewed, totaling \$3,010.

a) The Clarion Call did not submit a Revised Spend Plan to CSA by the deadline, so they have provided supplemental requests to present to the Senate so they can continue working as an organization this semester.

b) Questions

(1) Trustee Krupa - Are these supplemental requests for the entire year, a semester, or a specific publication?

(a) Most of them are for the year. The stationary and printing are hard to gauge for this year though.

(2) Trustee Krupa - What is the AP Content Access?

(a) Because there aren't always enough writers, in order to publish a whole paper, we are able to use some stories from Associated Press.

(3) VP Engleman - With nobody on campus, do you think you could look at decreasing the printing money?

(a) The plan is to revamp the website because none of the staff knows how to use it correctly, and it would be a better way to reach students this semester.

(4) Senator Windt - What does PDF hosting mean?

(a) It's where we put our archived issues as PDFs just in case people want to look at them.

(5) Senator Joseph - What is the mailing money used for?

(a) It's probably for mailing out bills for print and invoices.

(6) Secretary Robinson - Why is there so much money allocated for printing and stationary, and is it for the entire year.

(a) They're for the semester. The original printing budget is usually a lot higher with about \$3,000 for the semester.

(7) Senator Pletcher - How many people do you have on staff?

(a) An estimate would be somewhere between 10 and 12.

(8) VP Engleman - Would you be at all interested in dropping the requests for printing and stationary at this point?

(a) Yes, because the main focus is revamping the website.

(9) Trustee Krupa - Normally a supplemental request supplements your budget, but why didn't you submit a budget?

(a) We did before the pandemic happened, but the person who was in charge left after this year and didn't send one in for the revised spend plan, and we weren't able to turn it in on time.

c) The Clarion Call representative requested that the motions to allocate the \$700 for printing and \$300 for stationary be tabled.

(1) The Appropriations Committee moves to allocate \$1,100 for Associated Press Content Access. **Motion passes with a unanimous vote.**

(2) The Appropriations Committee moves to allocate \$460 for PDF Hosting. **Motion passes with a unanimous vote.**

(3) The Appropriations Committee moves to allocate \$250 for AnnWebsite Renewal. **Motion passes with a unanimous vote.**

(4) The Appropriations Committee moves to allocate \$100 for Domain Renewal. **Motion passes with a unanimous vote.**

(5) The Appropriations Committee moves to allocate \$100 for Mailing. **Motion passes with 8 yes, 2 no, and 1 abstain.**
