

Clarion University Student Senate Meeting Minutes
October 19, 2020

- I. Call to Order
 - A. President Mason called the meeting of the Fall 2020 semester of the Clarion University Student Senate to order at 7:33.

Students are simply overwhelmed by the extra amount of work due to being a synchronous class.
