

Clarion University Student Senate Meeting Minutes
November 02, 2020

- I. Call to Order
 - A. President Mason called the meeting of the Fall 2020 semester of the Clarion University Student Senate to order at 7:30.

 - A. Absent: Senator Spang
- III. Additions to the Agenda

- V. Student Concerns
 - A. Some CA's have been nervous about delivering food to quarantined students, and there are concerns about the increased number of students that may be on campus next semester. They do not want the duty to fall on them.
 - 1. It is currently understood that CA's are asked if they would like to, and they are not being forced to deliver meals.
 - B. There are concerns about what sanitation process and whatnot will be happening in the buildings for the Spring semester.
 - 1. All classrooms will be cleaned and sanitized after use. There are sanitization stations all over campus.
 - C. Some students have wondered about why professors are able to choose if they can teach classes that were supposed to be face to face as a completely web-based course.
 - 1. The university is trying to work with faculty with all the different concerns. Administration is working to try to give as many options as possible for professors to be able to teach the best way possible for students to learn the best way possible.
 - 2. If you're having a true problem with a web-based class of little effort being put in by the professor, contact the dean.
 - D. It might be beneficial if professors had to take some more training on Zoom and technology to help the classes run a bit smoother.
 - E. If you will not be on campus next semester, you should not sign up for a face to face class. If anything, you should sign up for one specified as multimodal.

 - a) Despite the integration, there will still be three separate campuses, but the biggest combination will be online. By pulling the universities together, there will be a more robust amount of courses offered online for students.
 - b) There will be one president of the three universities. The leadership offerings at all of the universities will have to be collapsed somewhat.
 - c) The main goal is to make college cheaper for students without cutting programs.
 - d) There is a lot of work involved and a lot of investigation. This is still in the works and not everything is known yet.
 - e) There are fourteen working groups that are going through the details, populated from people across all three campuses.
 - f) This is a 3-5 year process. In the end, it is going to be about reducing the cost for students and keeping quality education.
