Clarion University Student Senate Meeting Minutes

I. Call to Order

- A. President Zavinski called the meeting of the Fall 2021 semester of the Clarion University Student Senate to order at 7:31.

V. Student Concerns

- A. An English Professor took his mask off completely in a small class from the start. It reflects a bad image on professors if they are taking their masks off, especially with a mandate while in buildings, because students will then feel it is okay to take them off.
 - a. Face shields can be offered to professors to use for complications from the mask

 - 2. When would the university enforce the shut down? Would they play it by ear
 - 3. Accreditation process
 - 4. Surveillance on parties?
 - 5. Stadium is University property, so wouldn't it be overriding it when high schools use our fields and not follow our policy by following the county guidelines?
 - a. No stadium policy
 - b. No distancing requirements or spacing requirements in general, only mask enforcings
